



## GINA MILLER CALLS ON OFFICIAL OPPOSITION TO COMMIT TO FURTHER BREXIT VOTE

15 November 2018 – In light of the Brexit agreement agreed by the Cabinet last night, Gina Miller, the transparency campaigner, businesswoman, and founder of *End the Chaos!* - who ensured that MPs can now scrutinise and vote on the agreement - today issued a statement calling on the Leader of the Official Opposition to commit his Party officially to holding a further referendum on Brexit.

“I am calling today on the Opposition to face the changing reality of the present: the British people are increasingly disillusioned with what is being done in their name ... Our research shows that nearly four times as many Brits believe our present course does *not* represent the will of the people [58%], as those who do [16%].

“To know what the will of the people is now, it must be tested: Brexit must be put back to the public, so they can have the final say,” said Mrs Miller in an interview with Bloomberg this morning.

Mrs Miller also announced that her campaign *End The Chaos!* is today publishing its YouGov-commissioned research that clearly sets out the extent of public dismay over the Brexit process.

- 70% of the British public do not feel well represented by the Government in the Brexit negotiations. Of these, 39% feel “very badly” represented.
- This is 39 times the number who are enthusiastic: just 1% of the public report feeling “very well” represented by what has taken place.

Mrs Miller said: "This poll confirms that public opinion in our country has shifted considerably since the outcome of the EU referendum in June 2016. The British public no longer feel confident that what they were told about Brexit then is consistent with the options now being put before them. Nor do they believe that Brexit is now what they want for themselves, their families and their country. Our research shows that more people now think Brexit is not in the best interests of the British public than those who do (45% to 40%).

"I believe this gives reasonable grounds for believing that there is a gaping chasm between what the Westminster elite – and even some sections of our media – are saying and what a great silent majority of people in this country believe.”
